#### OFFICE ORDER

Sub: Procedure for issuing Form 26(6) to eligible MTNL employees/ex-employees for submission of joint option at EPFO portal under scheme EPS 95.

Ref: Letter No MTNL/CO/IRW/22(23)/2019/31 dated 19.04.2023

Consequent to the direction as per above referred letter, all GMs/CE(Civil)/ PCE(Elect) are hereby instructed to open a facilitation Centre in their unit to be managed by a nodal officer. Accordingly, Nodal officers have been appointed to facilitate all employees/ex-employees of MTNL to get Form 26(6) certificate and undertaking from WFMS as soft copy/printout on request. The list of nodal officers of each unit is attached at Annexure-A.

The Nodal officers would facilitate the working/ retired employees in their unit and follow the broad laid down procedure for providing the Form 26(6) certificate and undertaking to working employees/exemployees on request.

- 1. Working employees can obtain the Form 26(6) certificate and undertaking from the units where they are working or through Nodal Officers of concerned GM unit.
- 2. Ex-employees of MTNL can obtain Form 26(6) certificate and undertaking from the Nodal officer of GM unit from where they were retired.
- 3. In order to make the process smooth it is suggested that Nodal officer may issue tokens to the certificate seekers between 10:00 am to 12:00 pm on first come first serve basis and provide the certificate to them between 12:00 pm to 02:00 pm. Further, token may be issued between 03:00 pm to 04:00 pm and provide certificate between 04:00 pm to 05:30 pm or till all tokens are exhausted.
- 4. Nodal officers shall ensure that all requests received in a day should be disposed off same day. Also if required, the centre should be kept operational on holidays/Sundays.
- 5. The joint option form for higher pension scheme under EPS-95 is to be filled online by the employee/ex-employee. If required, they may seek guidance from concerned Nodal officer in case of any difficulty/lack of understanding.
